S/01/342/LB at Birchentree Farm, Cowgill, Dent, Sedbergh, Cumbria, LA10 5RQ - Listed building consent for removal of roof finish, careful storage of materials for re-use, repair and where necessary replacement of timbers, introduction of insulation between rafters, installation of breathable roofing felt, replacement of existing slating battens and replacement of roof finish in decreasing courses in a like for like method

S/01/341 at Settle-Carlisle railway line and adjacent land, off Cowgill, Dent, Sedbergh - Full planning permission for rail cutting stabilisation works, associated temporary site access, haul road and compounds
