PL256	/23	<p>New Applications:</p> <p>a) S/01/357 and S/01/357A/LB at East Clint, Dent - Full planning permission and Listed Building Consent for internal reconfiguration and extension of the existing dwelling; creation of external covered kitchen area; creation of car port with integrated fuel and garden store; installation of below ground LPG tank; replace existing septic tank with new package treatment plant and conversion of detached bank barn to guest accommodation with hard and soft landscaping and associated works</p> <p><i>Noted that it is unclear whether guest accommodation is for paying guests or family/friends. The council cannot support any applications for holiday let accommodation because of its own policy against this. Dentdale currently experiences a high percentage of holiday lets and the sustainability of the village and its infrastructure will suffer because of this.</i></p> <p><i>The committee understand the need to make changes to the principal accommodation and would support this provided the work was done sympathetically to the heritage nature of the building.</i></p> <p>RESOLVED to object to the application on the basis that it includes holiday let accommodation which goes against the councils policy.</p> <p>b) S/01/346A at Chapel Fold, Dent - Full planning permission for retrospective building operations and to reinstate the building to its former residential use by conversion of the building to a single dwellinghouse (part retrospective)</p> <p><i>The committee noted that this should not be considered as a new build but a rebuilding of an existing dwelling by a local resident. The committee considers that enabling local residents to remain in the dale should be encouraged.</i></p> <p>RESOLVED to support the application provided all works are done sympathetically to the heritage nature of the building.</p> <p>c) S/01/77C at Dent Stores, Dent - Householder planning permission for installation of Velux roof light into kitchen pitched roof</p> <p>RESOLVED that the council supports this application.</p>
